Meeting called to order by McMahon at 1:31pm

- **A. Approval of the Agenda-**Bell moves to approve agenda, Hubbard seconds

- Updates from the Chancellor's Cabinet-Dr. Hsieh reports that Miramar enrollment figures show a -2.1% below target D. for FTES. The District informed the College made a mistake in scheduling of public safety courses. That information was communicated to the district without the campus' knowledge. The district is currently -1.4% below FTES target. The Chancellor was hoping for a 1% rise above the target, as a result, the colleges need to look into the following areas: Evening courses-what is offered, what can be expanded and what is the capacity for evening courses and what is the projected FTES based on the colleges' plan; weekend class offerings; detailed analysis will be discussed at next Chancellors Cabinet. All research analysts will receive directive from Lynn Neault's office to focus on getting data for each college. Data will be reviewed by college president and the president will in turn go back to cabinet to present what are the proposed strategies to address the gaps and that meeting is scheduled for October 20. Dr. Hsieh stressed to the campus that we all make mistakes, but please allow the campus to address problems before they are reported outside of the campus. There was a proposal to have inter-session in the future. It was stressed that that inter-session would be for Winter 2017 and not Winter 2016. The Chancellor wants to know what courses Miramar will offer during a proposed inter-session. There is a one week turn around on this. Research shows that, in the past, 27% of the students who took inter-session courses are 4-year university students home on break while 44% were returning students. Research also indicates that inter-session does not interfere with spring enrollment numbers. October 8th board of trustees meeting is at Mesa College. Miramar has no items pending on the agenda. September 24th board of trustees meeting is at City College. On September 22, the cabinet approved two additional Miramar College classified positions that will be funded by SSSP money. Both are Senior Student Services positions. No update on the budget.
