#### Administrative Procedure

## AP 0505.02 - SMOKE-FREE DISTRICT PROPERTY ENFORCEMENT

November 8, 2012

#### BACKGROUND

This procedure outlines District protocols for implementing Board Policy 0505, Smoke-Free District Property including informing students, employees, and visitors regarding enforcement and consequences for violation of the policy. The success of this program is dependent upon the voluntary cooperation of the smoking and nonsmoking public. The District recognizes the fact that individual health can be impaired both by the direct and by the secondary effects of smoking. The District, therefore,-prohibits smoking on all properties and in all vehicles owned or controlled by the District.

## **PROCEDURE**

- 1. Smoking is strictly prohibited inside any building or in any outdoor area owned and occupied or leased and occupied by the District.
- 2. Smoking is prohibited inside any District-owned vehicle.
- 3. Human Resources will provide information to new employees regarding the District's smoking regulations and the availability of a Smoking Control Program.

#### **IMPLEMENTATION**

## 1. Responsibility

- 1.1 Primary responsibility for enforcement and education lies with the President at each college and Continuing Education for their respective campuses. Primary responsibility for enforcement and education at the District Office and District Service Center lies with the Vice Chancellor of Facilities Management.
- 1.2 Facilities Management will prepare and post "no smoking" signs on campuses and District property to notify students, staff, and visitors that smoking is prohibited.
  - District personnel will publicize prohibition of smoking in college catalogs, printed schedules, and other college material, and may take additional steps to educate constituencies on smoke-free policies and procedures.
- 1.3 College Police will provide training on enforcement of a smoke-free District for officers. College Police officers will inform visitors, staff, and students of the the District's policy and procedure prohibiting smoking on District property or vehicles. Any College Police officer may warn or cite any person who is in violation of this policy.

In the discretion of the officer, and based upon circumstances of the violation, an officer may report students who violate the smoking policy to the respective dean of Student Affairs for disciplinary proceedings under Cal. Ed Code Section76033(3). In addition, an officer may report employees who violate the smoke-free District property policy to their respective supervisor for disciplinary proceedings under the relevant employee manual or collective bargaining agreement.

The Chief of Police is responsible for implementing a system for College Police personnel to refer offending students to appropriate deans of Student Affairs and to refer offending employees to appropriate supervisors or managers.
