

COLLEGE EXECUTIVE COMMITTEE MEETING

Meeting called to order at 1:30pm.

- A. **Approval of the Agenda:** Hsieh motions to approve the agenda with a slight change. Items 1 and 3 will be tabled until Bell and Hopkins arrive at the meeting at 2pm. Murphy seconds. Motion passes.
- B. **Approval of Previous Minutes:** Hsieh motions to approve the minutes. Murphy seconds. Motion passes.
- C. **Guests/Introductions:** Laura Gonzalez, Adrian Arancibia.
- D. **Updates from the Chancellor's Cabinet:** Hsieh reports on enrollment ([see attachment](#)). The numbers remain the same as last cabinet whereby Miramar College is -27.5 FTES below target for the '17-'18 year. There is coding issue at this time that is preventing the proper collection of high school FTES. Ramsey says his office is addressing the issue. He hopes to have a report to Hsieh by the end of the week. The district is -455.0 FTES below what the District actually funded FTES for the year. That translates into \$2.3 million dollars invested by the District with no return on investment. The Chancellor has asked what can be done to address this shortfall. A district wide enrollment strategy workshop will be held on Dec. 11 to address this FTES shortfall. Hsieh encourages all the chairs to be involved in this workshop. There is a discussion at the cabinet level about how the San Diego Promise program will be used now that AB19 has been passed. The district's interpretation of first time, full-time students would include those students who took part in a dual or concurrent enrollment program while in high school. These students would still be eligible to receive the AB19 fee waiver benefit. This could change. The proposal is, that starting Fall 2018, the San Diego Promise would not fund first time, fulltime students but rather fund them in year 2 if they meet certain criteria. Hsieh will advocate to fund students from outside of our service area for year 2 of the San Diego Promise so we don't lose our current out of service area students to other colleges. There are no items pertaining to Miramar College on the Nov. 9 board meeting agenda and that meeting will take place at Mesa College.

1	Guided Pathways Next Step: Miramontez reports that last week Hsieh sent out an email on Guided Pathways and two key elements were noted: 1) PIEC is playing a role in coordinating efforts regarding dialogue 2) it was concluded that the rebranding of Guided Pathways wasn't the issue, but rather operationalize the dialogue. Grisham detailed the College's planning framework to illustrate how Guided Pathway's is already being undertaken. All 8 points of the principles of redesign are already in the College's planning framework. Grisham states that the College can't say it is doing "guided pathways" per say, but that the evidence presented proves the College is ready to move into a direction of redesign. McMahon states that there is good information presented here, however there should be foundational work through counseling and the faculty to lead the project and create the curriculum. Murphy is concerned about the terminology, in that the "tool" is being presented with no input from constituencies. She states that this implies "here is what we are going to" and questioned who created this tool. Grisham confirmed that it was Grisham and Miramontez that had created the tool. 	<p>has an opportunity to really look at this with a different perspective and not force what the College has done in the past to make this work for the College now. Murphy states that the College needs to take a step back. Hsieh reminds everyone that new legislation shows that the College must apply for this guided pathways grant or risk losing funding for AB19. McMahon states that there is a state-wide senate resolution asking the State Chancellor to make exceptions to the AB19 guidelines. McMahon states that the take home message from this discussion is that this sense of urgency to get started on guided pathways needs to be reigned in and involve faculty and senate directly. Ramsey agrees that the sense of urgency needs to be directed at the State Chancellor's office, but as in institution at the best case scenario it would be irresponsible to not look at fairly aggressive timeline, but not at the expense of being thorough. Hsieh adds that we are not doing this plan because we have to, but because the college continues to enhance its ability to better serve our students which is the essence of the student experience focus planning framework. Murphy requests that a work group be created to better assess this and get faculty more involved. Hsieh says that work groups will in fact be created in the future to get everyone's perspective, but we have to start somewhere. Miramontez pointed out that this document is just marrying two things together and mapping it "this is what the college has done to date and this is what the state has given us." Ramsey recommends that another meeting be called to continue this dialogue with the College. McMahon specifically requested that no dates for workshop/meetings be sent out until after she has a chance to confer with the Academic Senate later that day.</p>
