1) Improvement Recommendations

- a. **Improvement Recommendation 1**-In order to increase effectiveness and better determine whether its mission directs institutional priorities, the ACCJC team recommends that the College engage Administrative, Instructional Support, and Student Services programs in program review to address how well program missions align with the College mission.
  - i. **Update:** For the Instructional Support Services area, the next program review will include a full review of all departments, including the mission statements, as it relates to the College mission. The next full program review is scheduled for fall 2018 (Evidence: Instructional Support Services Program Review and Assessment Schedule).
  
- b. **Improvement Recommendation 7**-In order to improve effectiveness, the ACCJC team recommends that the College aligns its plans for technology support staffing needs with its capital improvement projects.
  - i. **Update:** The College has responded to this recommendation on two fronts:
    - 1. The College has aligned its technology operational plan with the District's technology master plan (Evidence: San Diego Miramar College Technology Plan 2.0 Fall 2017-Spring 2020).
    - 2. The District is at the beginning of creating a districtwide technology committee. Names have been forwarded from the College to the District as potential members (Evidence: District Technology Committee Email 10.09.17).
