- 6. Pablo will be presenting the ESC's goal/proposal at the next Facilities meeting on Nov 5, 2020.
 - a. The following is a proposal the ESC would like to make to the campus and the District Sustainability committee. Based on discussions at the ESC over the past year as well as discussions at the past two district meetings, we would like to move away from single use plastics. We would like to propose to the district committee and present to the Academic Senate: "The Miramar ESC is in support of the district phasing out single-use plastics, and not selling, buying, or signing new contracts that promote single-use plastics with the goal of zero single-use plastics by a future date."
 - b. Things to consider:
 - i. The end date should be based on input from all stakeholders, with the goal of reaching zero single-use plastics as soon as reasonably possible
 - ii. We should probably address the Covid and sanitation concerns around reuse vs. single-use products
 - iii. We'll need to consider the lack of and expense of dishwashers, etc.
