#### **New Business**

### • Classroom AV Prioritization

Bell discussed the annual process that is facilitated through BRDS

- o To support the replacement of classroom AV
- o Budget is \$50,000
- o There are 16 classrooms in priority order that need replacement
- o Communicated the status of process
- o Estimates that BRDS may be able to fund 13 of the needs

Brandt questioned what happens to the items that are not funded. Bell stated that it will go to the next year's list. Encourages everyone to go to their Deans, if there are AV items that are not working.

Motion to approve prioritized classroom AV replacement list, Booth, Pacheco, MSC.

## • BRDS RFF Purchasing Update

Bell thanked Denise for tracking all of this and keeping everyone updated. Many of the requisitions were completed and approved prior to the end of December. BRDS approved RFFs of \$225,624 there remains an unspent balance of \$7,740.

Hill explained when and why we replace servers. Buser questioned if there is a list of life expectancy and when things will be expiring. This will allow members to see when end of life of servers are coming up. Hill stated that they are driven by a number of things and expects 6-7 years for a server. A discussion of whether different Web servers can be used.

## • 2021-2022 Tentative Budget Development

Bell shared the form used for the discretionary tentative budget development process. It will be starting in March, in order to have communication for all departments. The documents serve as a basis for discretionary budgets.

Bell explained Adopted Budget process that includes the allocation of new Discretionary resources.

Bell announced that we will receive HERF II Funds. He explained how the funds will be allocated.

- Only credit colleges distributing financial aid get funding
- The District will re-allocate funds allocated to City, Mesa, and Miramar to include the College of Continuing Education and District.
- Budget Planning is in progress
