On January 2nd, Assessment testing will be offered on a walk-in basis between 8:30a.m. – 2:00p.m.

Students may clear prerequisites if they have AP Credit or College level credit for English or math; Students that have qualifying SAT scores: Engl (Critical Reading) 550 / Math 570,

ACT ENGL 22, ACT MATH 23, EPT 147 or ELM 50;

SBAC: "4" Exceeds Standards / "3" Ready (conditional - must complete approved course work senior year and provide official transcript), AP test scores of 3, 4 and 5.

Who should take the Assessment test?

- > Plan to take a English or math course
- ➤ Plan to take a course that has an English / math prerequisite
- ➤ Plan to obtain an associate degree or certificate
- ➤ Plan to transfer to a four-year college or university

The English Assessment Tests:

There are two types of English tests: The English assessment for native speakers, and English Speakers of other Languages (ESOL) assessment. It is important that students take the right test. Students who take the wrong test often waste many semesters taking classes that are too difficult.

Test Exemptions: In order for test exemptions to be considered, students must submit official test scores to the District Student Services for review. Unofficial copies cannot be accepted. For students with EAP / CAASPP exemptions, please call 619.388.6937. AP Test scores must be officially submitted via transcripts and official qualifying scores through the College Board of three or higher. Please see a counselor to initiate a formal evaluation of AP completed course work. Alternative measures of standardized tests must have been completed within the past two years.
