 - (1) D. Short stated the Miramar Exercise Science department approves of the proposals with the exception to the Distance Education (DE) component. He noted that the district considers DE to be an individual college decision.

 - (1) D. Short stated PSYC 201 and 258 are being proposed for fully online DE. They currently have online-emergency only DE. They had originally been part of the last meeting's agenda but were removed since the proposals must be submitted in a revision format if revising an already existing DE approval.
 - (2) The committee discussed the approval timeline for regular DE in conjunction with the possibility of returning to in-person instruction at the Miramar campus by the Spring 2022 term.

- b) New CSU GE ethnic studies requirement
 - M. Sanft stated CHIC 110A recently had been approved for the CSU GE Area F requirement. The CSUs have denied a large number of proposals from other California community colleges with the justification that the core competencies are not reflected in the courses.

The Articulation Officers and Chief Executive Officers have raised the issue. The CSUs plan to host a webinar on May 12th and may allow an appeal process with a deadline to submit by June 1st. Miramar would like to review the proposals once more and move forward with an appeal in coordination with City, Mesa and the District Office.
