- A. Support for Piano [Latinx, Muses] | 15 minutes
  - a. Tabled until after New Business
  - b. Latinx Representative motions to bring this item off the table
  - c. Senator Amaan seconds the motion
  - d. Professor Booth is trying to find a piano that is studio recording quality, says that there are 2 pianos on campus but one of very old and almost broken and the other is \$6,000 and constantly needs to be tuned, a recording studio quality piano is around \$45,000, ASG students should go and find a donor or fundraise from the community
  - e. Advisor Joseph asks if the other SDCCD colleges has had success, Professor Booth says that city college recently got a piano and although mesa college gets community donations and probably wouldn't be willing to part with a good piano, important to get a piano because it is unreasonable for him to be there to tune the piano every time anybody needs to record
  - f. Senator Kayla asks if we have any money kept for this, Professor Booth says that there may be around \$5,000 that would be possible but very unlikely, Advisor Joseph asks what kind of piano would be necessary, Professor Booth says that it needs to be a 6 foot grand piano
  - g. Latinx Representative says that ASG should make a flier in order to inform the students that the Music Club was looking for a Piano, Advisor Joseph asks if they had considered making a promotional video
  - h. Advisor Joseph says that if they able to find 4-5 music students production of a video promoting getting a piano for Miramar College can be sent out to donation programs
